BELIA report - Eurasian Milfoil study is complete. Very South side and very North side have some milfoil. The BELIA board meets tonight to discuss whether to treat for milfoil this year. This will also help determine how much funding they are able to [provide toward the ELID dosage study.

Old Business: Dosage Study All agreed that regardless of BELIA funds, we should proceed with our plans to go door to door asking for ELID member donations for the dosage study. Harry will help coordinate this effort on spreadsheets, while Ken will divvy up parcels for each volunteer to solicit. We currently have 11 volunteers, Mike will ask for more volunteers at the BELIA board meeting tonight. We will start as soon as we receive our parcel and hope to complete this by the end of July.
